


04 February 2023 Policewomen Reunion Lunch

06 Update on Death and Disability Insurance (DDI) for members aged 55 and over

Some of you may have heard about the recent changes to Death and Disability Insurance (DDI) cover for Victoria Police members and those who have retired on grounds of ill health since 1 July 2022. TPAV has been involved in lengthy negotiations with the Government to fill the gap in DDI for members aged 55 years and over. The gap has prevented members between 55 and 60 years of age from accessing DDI cover. This has meant that these members were only entitled to a retirement benefit from ESSSuper, equivalent to their accrued benefit.

TPAV advises that their negotiations with Government have concluded and that, for the first time, members aged between 55 and 60 years can now access a form of DDI cover. This extends to those who have retired on grounds of ill health since 1 July 2022.

The result is an insurance-type product that will benefit members who have turned 55 and retire because of ill health. This will eventually be reflected through an amendment to the Emergency Services Superannuation Act. Until the amendment is achieved, Government has agreed to establish a dedicated fund to provide the benefit to eligible members. Eligibility for the payment is determined based on the threshold for an ill-health benefit under the Emergency Services Superannuation Act.

The benefit is paid as a lump sum that is calculated with regard to your age and a percentage of your final average salary, as follows:

The contingency fund will operate retrospectively from 1 July 2022. This means that if you have left the Force on or after 1 July 2022 between the ages of 55 and 60 years on grounds of ill health, you may be entitled to a lump sum payment in accordance with the above table. Please note that the payment will be in addition to your accrued ESSSuper benefit.

The scheme is administered by the Department of Justice and Community Safety (DJCS). They will liaise with Victoria Police to ensure eligible members receive their appropriate lump sum payment. cont.



07 Update on Death and Disability Insurance (DDI) for members aged 55 and over (cont.)

How to make a claim

There are four possible scenarios that may apply, depending on your situation:

- 1. Current members can apply to ESSSuper in the usual way indicating they are retiring on grounds of ill health. ESSSuper will obtain your permission to provide your details to DJCS to enable eligibility to be assessed.
- 2. If you have already retired since 1 July 2022 and have advised ESSSuper at the time you were retiring because of ill health, ESSuper will request your consent to provide your details to DJCS. They will contact you to arrange an independent medical examination. If the examination concludes you meet the test for a disability benefit under the ESSS Act, then DJCS will determine the quantum. If the initial examination does not assess you as meeting, the test you will be sent for a second examination. Similarly, if you are assessed as having met the test, DJCS will determine the payment.
- 3. If you have already retired since 1 July 2022 and you didn't advise ESSSuper at the time that you were retiring because of ill-health, you should contact DJCS via email at <u>policecontingencyfund@justice.vic.gov.au</u>
- 4. A member has died since 1 July 2022. ESSSuper will advise DJCS who is administering the benefit and that a death certificate has been provided. DJCS will arrange payment to the deceased member's estate.

08 The Restorative Engagement & Redress Scheme

*Please be aware that this article discusses sexual harassment.

Since its establishment, the Restorative Engagement and Redress Scheme has helped many members who have experienced workplace sexual harassment and sex discrimination to seek support and be heard.

The Scheme offers a range of options to former and current Victoria Police employees who have experienced workplace sex discrimination or sexual harassment, including counselling, a restorative engagement process and financial payments.

It is facilitated independently of Victoria Police by the Department of Justice and is all about acknowledging the wrongs that have happened in the past.

Participants may choose to participate in restorative engagement, which involves taking part in a conference (a private meeting) with a senior representative of Victoria Police to discuss their experiences, ask questions, and raise awareness of organisational improvements and strategies to prevent others experiencing what the participant experienced.

Restorative engagement conferences are available face to face through an online video meeting, or through the telephone or letters. They are a safe and constructive discussion. It does not involve any alleged perpetrator. Rather, it is an opportunity to share your personal experience with a senior Victoria Police representative in a confidential environment.

Senior Victoria Police staff have undergone specialised training to act as a Victoria Police representative in the restorative conferences.

Participants' feedback about restorative engagement has been positive, with members reporting they felt believed, the Victoria Police representatives were empathetic and authentic, and that the process was healing for them.

TPAV has supported members through the restorative engagement process, including by attending the conferences as a support person.

If you have a lived experience of workplace sex discrimination or sexual harassment within Victoria Police, we encourage you to consider participating in the Restorative Engagement and Redress Scheme.

Faye Sheehy (V108928)

Faye Sheehy was a much-loved member of the Victoria Police family as evidenced by the two tributes provided for us.

Janet Mitchell writes, PPWPA retired VPS Faye Sheehy passed away on 31 December 2022. She was the much-loved mother of our members, Marnie and Sally. Faye worked with Victoria Police for a total of 20 years between 1959 and 2003. Faye was a friend to all, an ally and supporter. During Faye's service at the Police Academy chapel, the Rev. Jim Pilmer observed in his introduction, "This isn't a full honour's Police Funeral, but it might as well be – we have the Chief Commissioner and three Deputies present. The chapel was full with many wonderful stories told. If you knew her, the stories will make you smile, if you didn't, you might wish you had. Faye was a friend to all, an ally and supporter. She is greatly missed.



Rod Porter, another friend of Faye's writes:

Faye was born on 24th October 1938 in St Kilda. She attended St Kilda Primary School with Graham Crawford, a life-long friend of Faye's, and who later became a Superintendent with Victoria Police. Her friendship circle was wide and varied: another life-long friend was 'Prisoner' star, Sheila Florence.

Faye was not only talented but also beautiful: she was runner-up in the Victorian Beach Girl Contest in 1957. In 1958, she won three State badminton championships and played an exhibition match with the Prime Minister of Singapore, Lee Kuan Yew. She later said she let him win so as not to embarrass him.

Like her friendship circle, Faye's work life was varied. She did many voice overs for ABC television and radio. She worked on the movie 'On the Beach', filmed in Melbourne in 1956 starring Gregory Peck and Ava Gardner.

In 1959, Faye joined Victoria Police as an unsworn and commenced work at the Police Depot until 1962. Faye later worked as a personal assistant to a number of the Executives at Channel 2, Elsternwick & at Channel 9.

Taking time off after the birth of two daughters, Faye returned to Victoria Police in 1987 as a receptionist at St Kilda Road Police Complex. In 1991, she transferred to Prahran Police Station. After the deaths of Steven Tynan and Damian Eyre, Rod Miller and Gary Silk, Faye was relentless in ensuring that a memorial wall in the foyer of the police station was erected in their memory. The project earned her a Chief Commissioner's Commendation, presented to Faye by the then Chief Commissioner, Christine Nixon.

Remembered as true and loyal friend, Faye had a knack for cheering up those who were down. With a great sense of humour, inappropriate language and a pen chance for talking over people, Faye was dearly loved and held in high regard.

Yvonne Robyn Eastaugh 18435 PW44

Yvonne joined Victoria Police on May 13, 1974. Working in many areas, she was stationed at Russell Street General Duty, A District Women Police General Duty, South Melbourne Policewomen's Duty, CIB Investigation Duty, CIB Drug Bureau, Licensing Gaming and Vice, Heidelberg Supervisor Duty and CIB Drug Squad, Kew.

Yvonne resigned on July 1, 1989 at the rank of Senior Sergeant.

Awards and Medals:

Commended for "initiative, diligence and intelligent interrogation, which resulted in the apprehension of four female offenders for theft, unlawful possession and several other summary offences" – 9/12/1975

Commended with one other for "courage, initiative and outstanding dedication to duty during an investigation which resulted in the arrest of four persons for trafficking in drug and a seizure of a large quantity of Indian Hemp" - 30/5/1980

Awarded the Chief Commissioner's Certificate for "professionalism, imitative and excellent teamwork displayed over a period of twenty-two months as a member of a joint Victoria Police and Australian Federal Police Task Force which resulted in the arrest of a number of persons on twelve counts of conspiracy to import narcotics into Australia" – 31/10/1983.

Commended for "dedication, initiative, and courage leading to the arrest of a potentially violent offender" – 12/2/1985.

Yvonne passed away on January 16, 2023 at the age of 69 years.

- Applications close on 12 September, 2023.
