Inspector Lilian Christina Irwin Registered no. 13868 - P/W 64 11 May 1927 to 17 June 2023

Record of Service as presented by Inspector Gerry McKenna at Lil's funeral on 28 June, 2023

Fondly known as "Lil"

It is my honour to be standing here today as a current inspector, before one of the most influential trailblazers and fellow female inspectors. Lil's determination and drive to progress women in leadership roles ensured others like me could progress to officer rank.

Lil was a pioneer of women and one of the foundation members of PPWPA – Past and Present Women Police Association, since 1993.

Up and until October last year, we were honoured by Lil's smiling face at our biannual lunch catch ups.

Lil attended February policewomen's reunion dinners on the last Friday in February at the Collingwood Football Club. Lil was awarded her 25 year PPWPA membership pin on 22 February, 2022. Unfortunately Lil was 13 days short of reaching her 30 year membership. As the president of PPWPA you think I would have some pull here.

#### Service History

3/3/1961 - Joined VicPol.

23/6/1961 - Graduated 5th of 24 recruits.

Supt. Whiteman stated Lil was an intelligent and industrious policewoman; her mature outlook has an influence on younger members of her squad.

26/6/1961 – Commenced beat duty at Russell Street.

18/5/1962 – Commended with 2 others for alertness, keen observations and devotions for locating a stolen car, which resulted in the apprehension of 3 offenders.

13/8/1962 – Transferred Morwell in 'D' & 'N' District performing policewomen duties

12/6/1963 – Transferred to St Kilda performing policewomen's duty.

30/4/1964 – Commended for alertness, courage and devotion to duty by the arrest of 2 thieves who operated at Caulfield Racecourse. cont.

13/7/1966 – Transferred to Russell Street on promotion to Senior Constable.

Supt. Hickey described Lil as well conducted an efficient. 10/12/1969 – Transferred to Morwell performing policewomen's duty.

Supt. Comrie described Lil as well conducted and reliable. 21/6/1971 – Transferred to "X" District on promotion to Sergeant, performing policewomen's duties

27/9/1971 – Transferred to Dandenong Women's Police Division. 28/2/1972 – Moved to general duties in Dandenong Operations Dept.

21/9/1972 – Attended and passed sub-officers training course no 50.

23/3/1974 – Promoted to Senior Sergeant at Russell Street.

4/6/1975 – Transferred to Fitzroy in charge of policewomen.

4/7/1977 – Transferred to 'O' District as Inspector.

1/8/1977 to 30/9/1977 - Long service leave.

Upon return to work completed and passed Officers Course No 28.

We thank you for your service and may you rest in peace, your shift is completed, time to log off.

described Lil as being a capable
officer who has given good

#### Senior Sergeant Michelle Maree Kerley - 25714

Michelle joined Victoria Police on September 15, 1986 and was stationed at Thomastown, St Kilda and after passing DTS at Licencing & Gaming. Michelle resigned on March 5, 1997 and rejoined on June 18, 2001. She was stationed at Williamstown, Altona North CIU, Purana Task Force, and Petra Task Force. Whilst at Purana, she received a Chief Commissioner's Commendation. Michelle completed temporary duties at the Academy as a Law Instructor in 2009 and in June 2011 was promoted to Sergeant at the Special Projects Unit. In January 2013 Michelle transferred to Professional Standards Command as a Detective Sgt and then in December 2015 to Darebin CIU. On June 6, 2021 Michelle transferred to Swan Hill as the officer in charge.

Michelle passed away on June 18, 2023 at the age of 55 years.

### **Spring Recipe**

### Sour Cream apple slice - no frills



- 1 packet butter cake mix (woolies have one)
- 1 cup of coconut
- 125 gm marg or butter
- 1 carton sour cream
- 1 tin pie apples (2 cans of pink lady apples from Aldi is good too!)

### **Prepaid funerals:**



Perhaps the best time to arrange a funeral is before it's needed, without the emotion and stress that often accompanies a death. Taking out a pre-paid, Fixed Price Funeral Plan is as much a part of caring for your family as preparing a Will. What if Tobin Brothers went out of business? Should Tobin Brothers cease to operate, another Funeral Director would fulfil the Funeral Service obligation as funds are securely invested with an impartial investment institution.

Does a Fixed Price Funeral Plan affect Centrelink Pension? No, as the investment cannot be accessed it cannot be used to generate income for you and therefore is not subject to the Income or Assets test.

If a Fixed Price Funeral Plan is not right for you, another option for pre-planning it so use our very helpful brochure entitled "Statement of Wishes". This can be downloaded from our website and provides a structure to write down funeral instructions and family history details for future reference.
